A write-in candidate for such office shall file his or her initial Financial Disclosure Statement no later than twenty-four (24) hours from the date of the filing of his or her affidavit for a write-in candidacy.

3. This Financial Disclosure Statement **does not** require any elected official or candidate to disclose any specific dollar amounts or the names of individual clients or customers of business listed as sources of income.
4. The Code of Ethics for county and city officials in Hardin County, Kentucky, is available from the Hardin County Clerk for county officials and from the respective City Clerks for officials of the cities of Elizabethtown, Radcliff, Vine Grove and West Point.

K. Penalties:

1. **Failure to file a timely Financial Disclosure Statement may result in a civil fine up to FIVE HUNDRED and 00/100 DOLLARS (\$500.00) payable to the Hardin County Board of Ethics.**
2. **Signing a fraudulent Financial Disclosure Statement is a Class A Misdemeanor.**
